

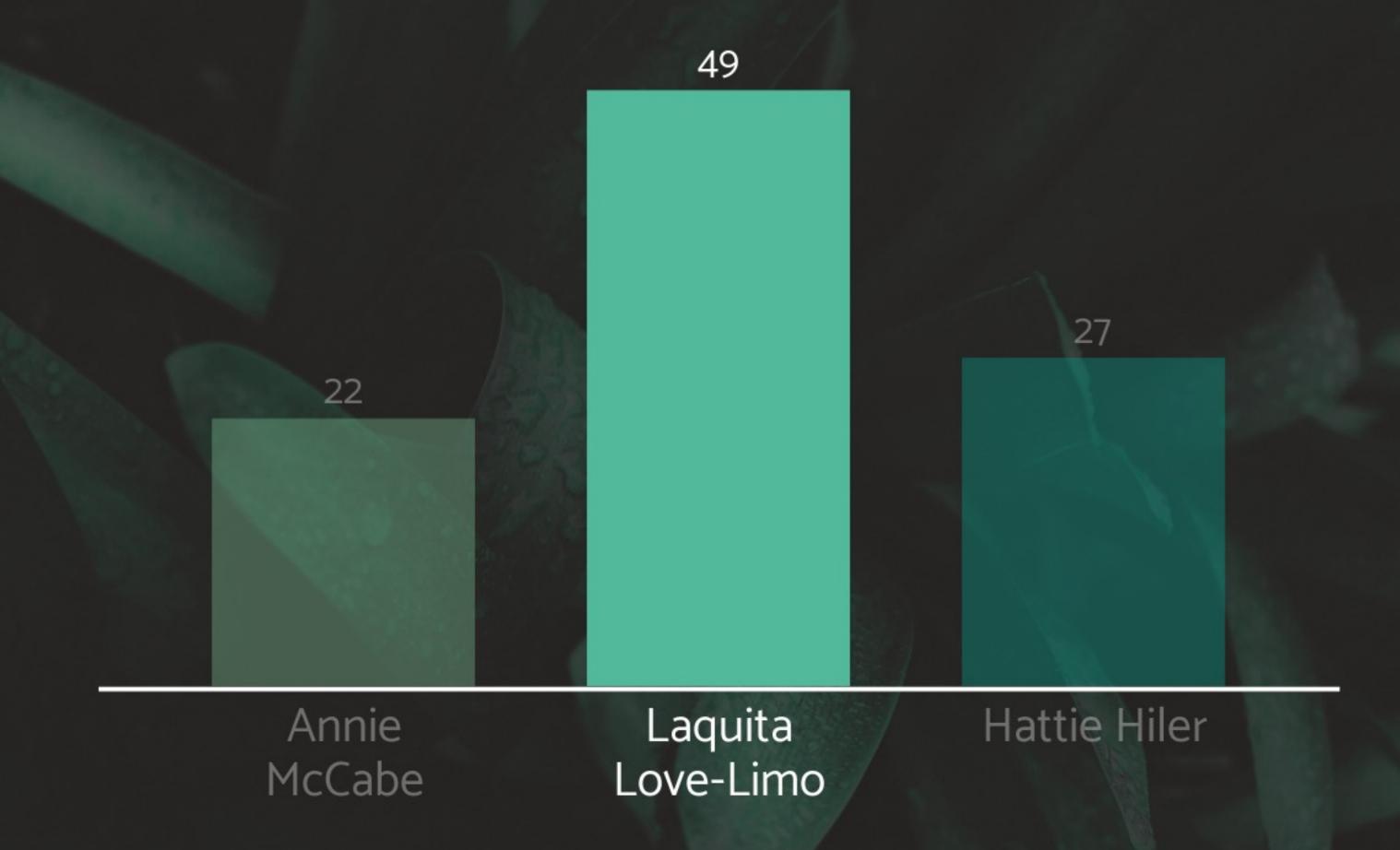

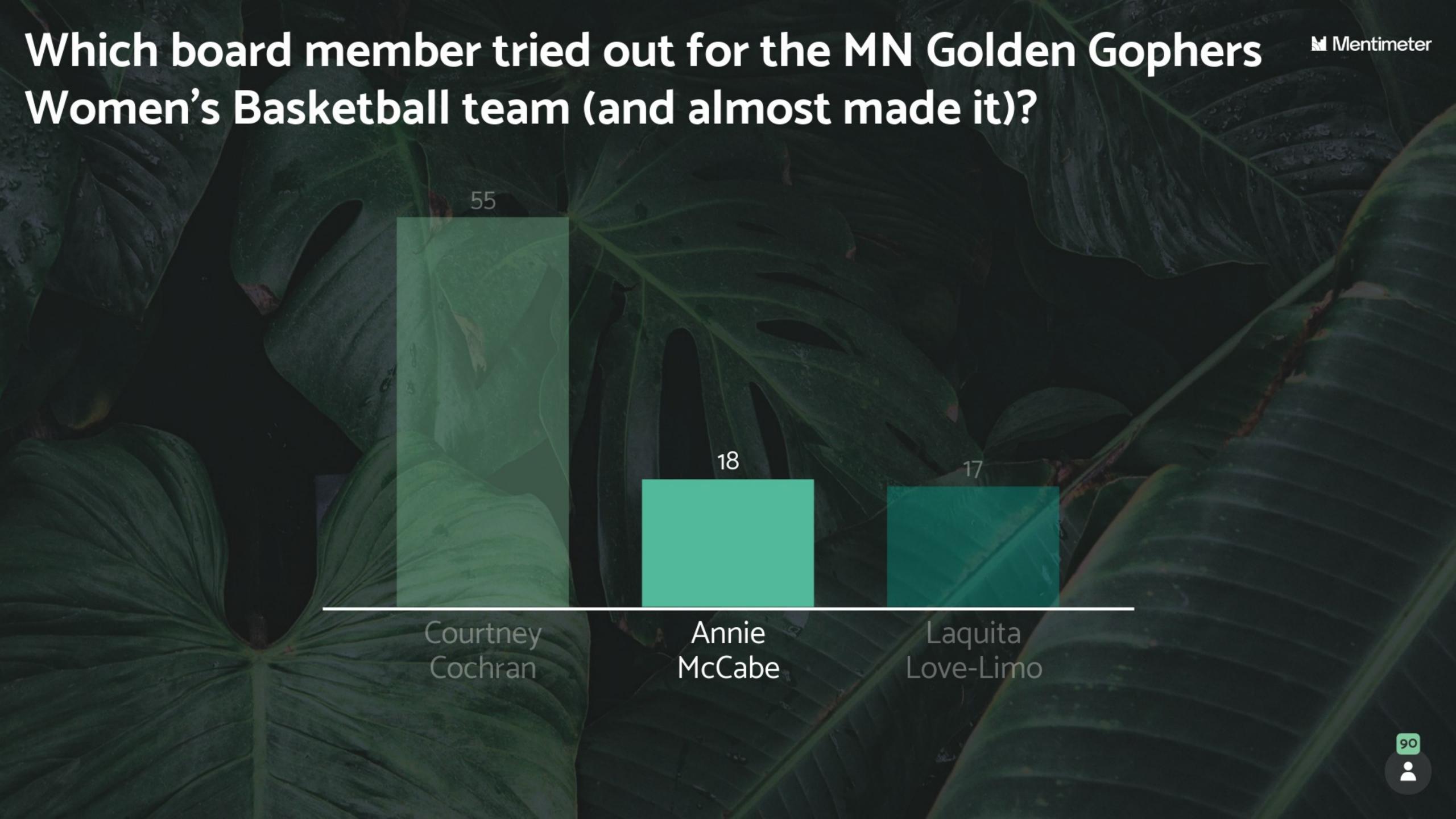

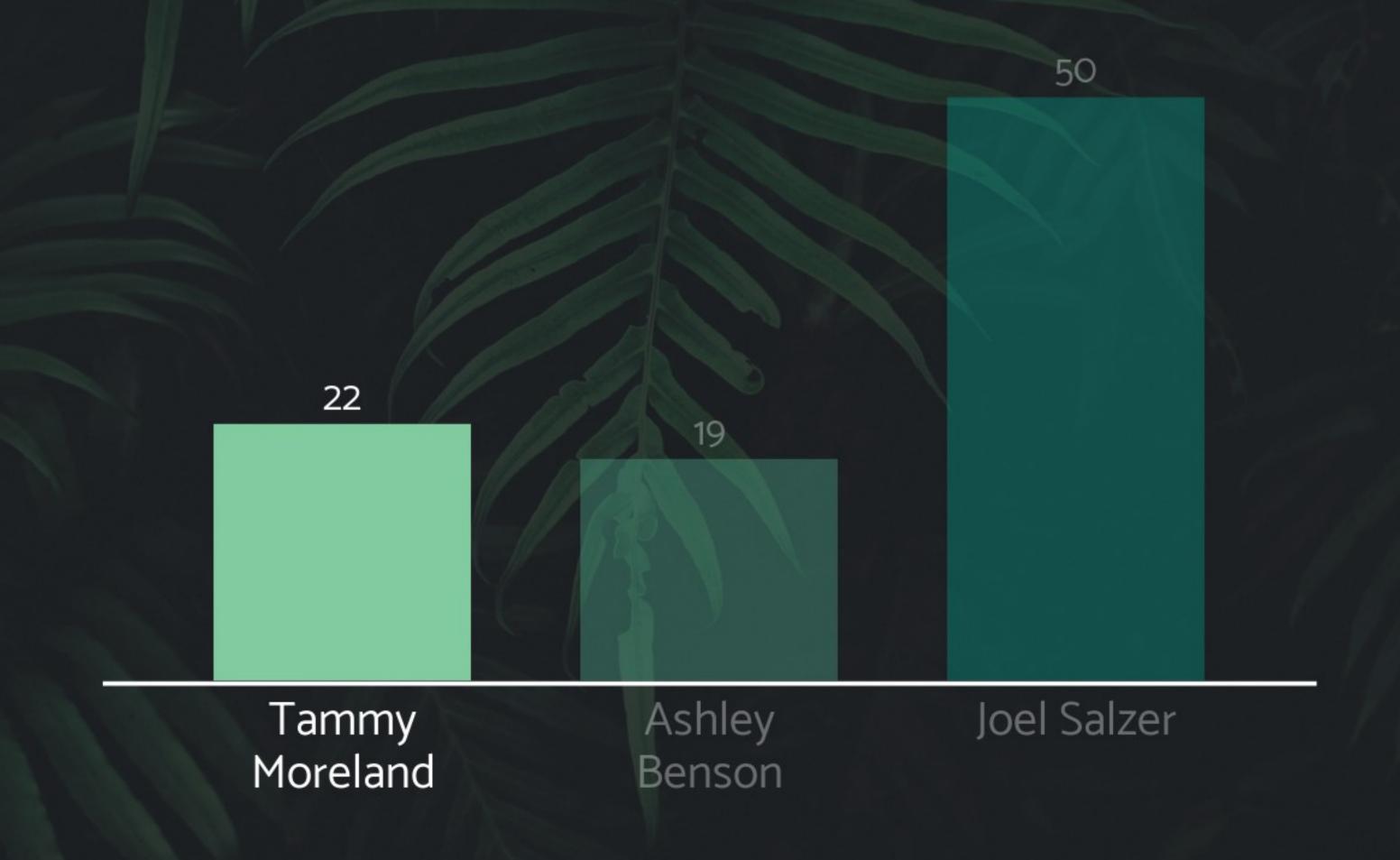
Which board member is a certified phlebotomist?





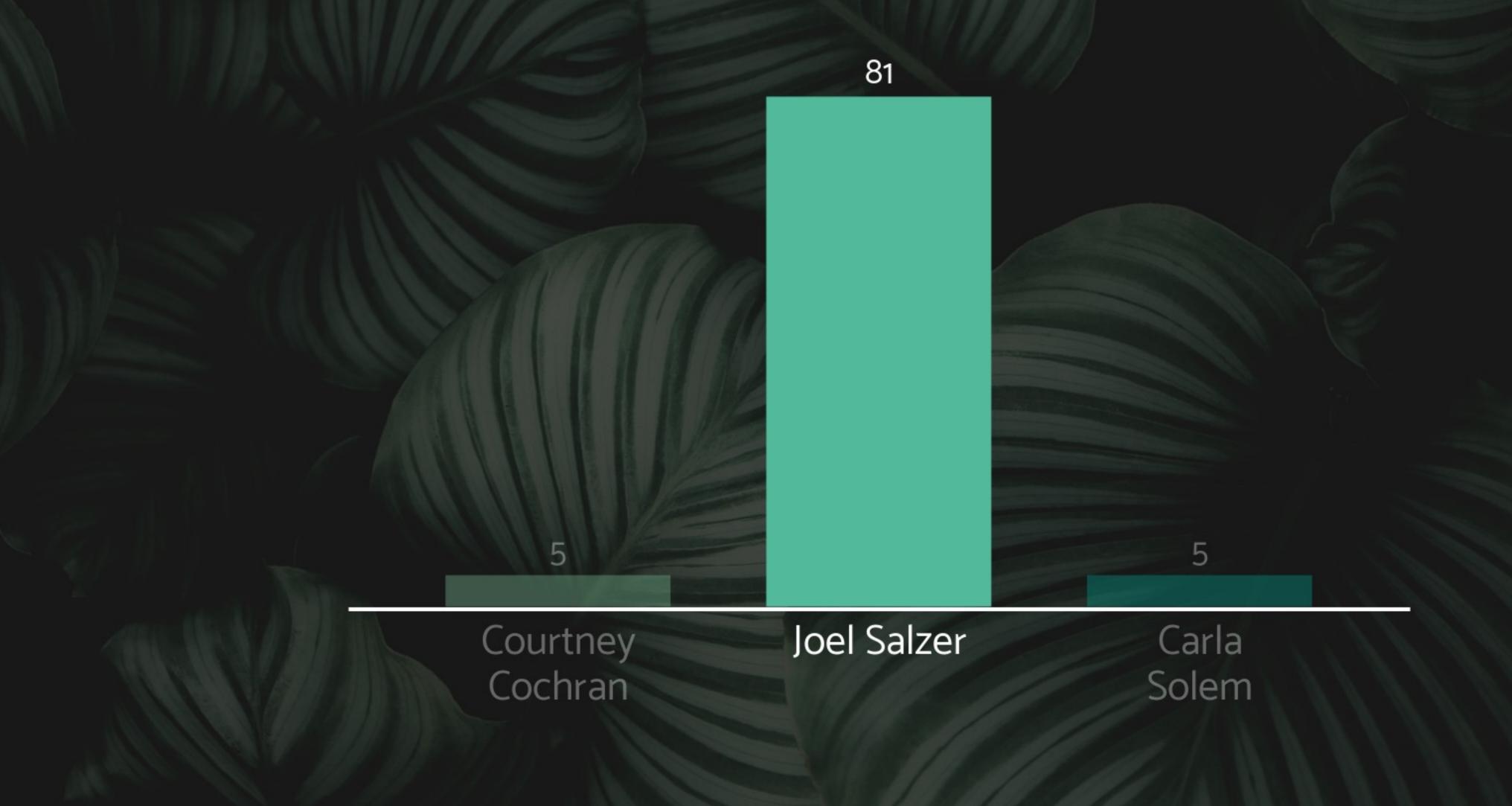


Which board member was afraid of the boogie man as a child?



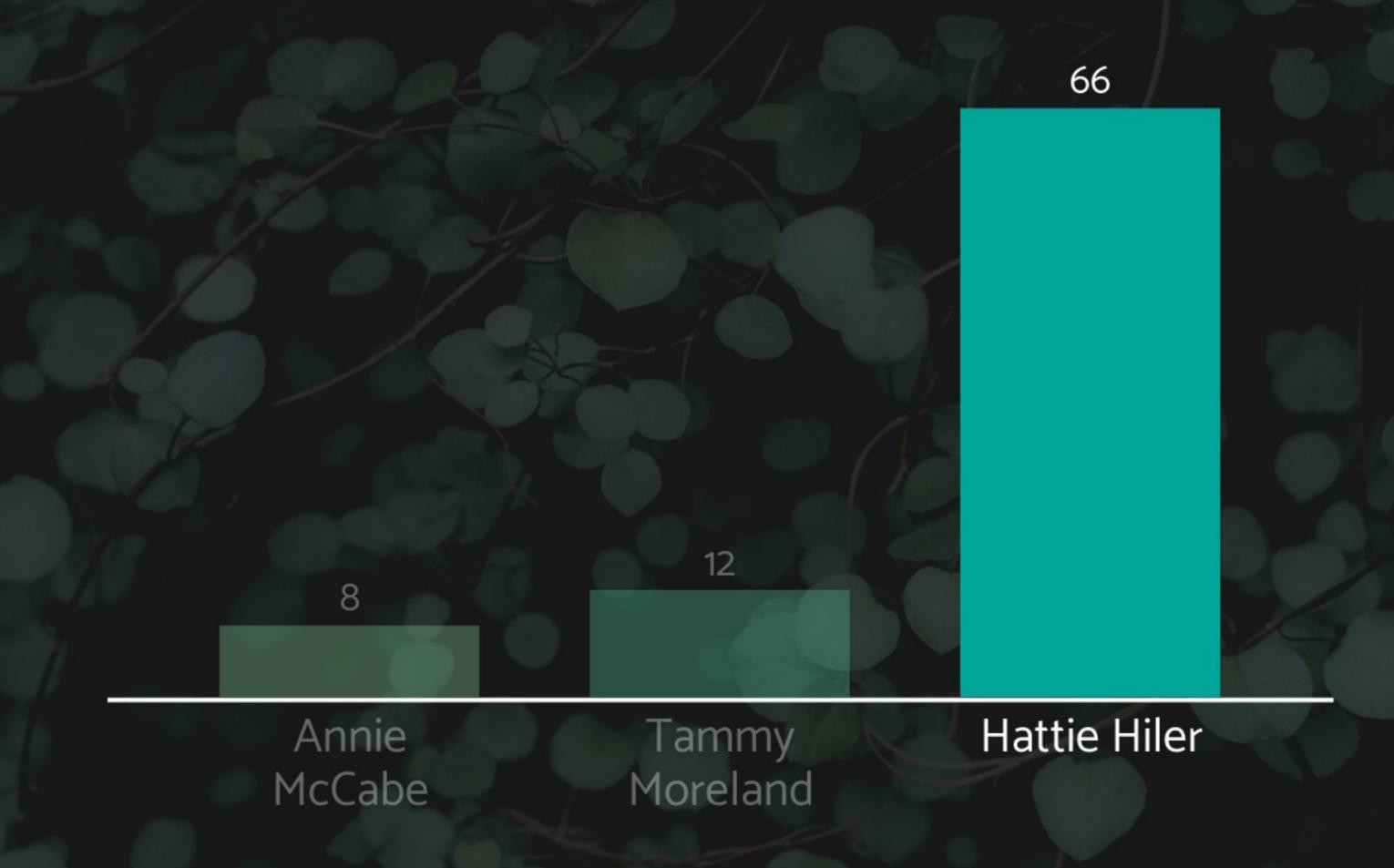


Which board members oven broke the night Jimmy Fallon was coming to his home for dinner?

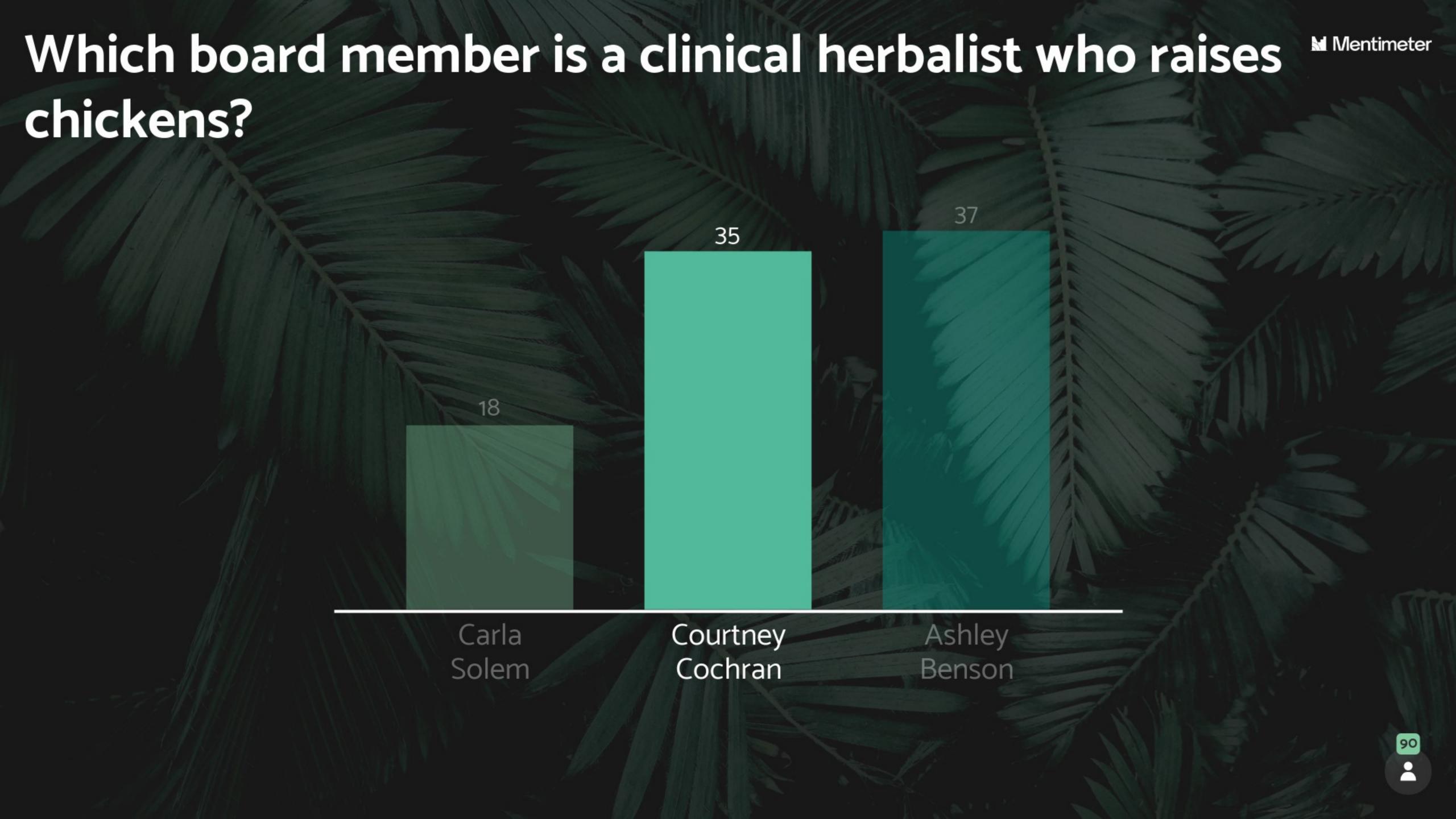




Which board member has only lived in M states?

Make real time changes in priorities and outreach for our community

Help reduce trauma on client by collecting progressive (need to know data) and data sharing.

Submit hmis reports directly to funders rather than having to submit data in another format

Better interface with street outreach and warming centers

Have QDQ better match areas funders evaluate

Coordinate care, support and resources.



Report the data back to people who are in the system

Shared data is only visible, Other agencies do not have the ability to change

Check CES status more easily

Provide data and interpretation for funders and policy makers on the most effective interventions and where funding should be prioritized. Gaps in housing openings visible in HMIS need to be used by funders to prioritize investments in new housing

Be able to bypass Race question required by HUD if ethnicity question is answered

Data analysis support for CoCs, state agencies, providers, and lived experience groups

more streamline CE process, better data quality (more client level UDE data and not individual ee or assess level data

The ability to view data by agency- Not Project -for larger agencies to monitor.

Find ways for agencies to add data that aren't 'required' to use HMIS. Ex., emergency shelters.

If we have done a CE assessment on a household and they come back to us letting us know that they have been accepted into a unit, allow us to pull their name even if they may not be at the top of the list.

Knowing what each specific data point is used for so it can be clearly explained to clients and staff so that everyone understands the purpose.

More case management training along with information transferring to new projects easier
